1. Marriage In The Old & New Testament:

Marriage – Merriam-Webster's definition in 2003 said "a: the state of being married b: the mutual relation of husband and wife: WEDLOCK c: the institution whereby men and women are joined in a special kind of social and legal dependence for the purpose of founding and maintaining a family."

Merriam-Webster's definition in 2006 adds: (2): the state of being united to a person of the same sex in a relationship like that of a traditional marriage"

Marriage is the *first institution* that God creates.

4. Homosexuality, Is It Really Gay?

How did the term "gay" come to mean "Homosexual"?

Is Homosexuality Really Gay? Is Homosexuality a Harmless Lifestyle? Does The Evidence Match The Portrayal In The Media?

- 1. Sexually Transmitted Diseases Are At Epidemic Proportions Among Homosexuals:
 - HIV/AIDS: The Centers for Disease Control reports that, as of Dec. 1999, "men who have sex with men" and "men who have sex with men and inject drugs" together accounted for 64% of the cumulative total of male AIDS cases.
 - Homosexuals are approximately 5,000 times more likely to contract AIDS.
 - 50% Homosexual males are believed to be HIV positive
 - Approximately 70 percent of those who have died are homosexuals.
 - Thomas E. Schmidt, Straight and Narrow? "It appears that at least 75% of homosexuals are currently carrying one or more pathogens"
 - Human Papilloma virus (HPV): According to the homosexual newspaper The Washington Blade, "A San Francisco study of gay and bisexual men revealed that HPV infection was almost universal among HIV-positive men, and that 60% of HIV-negative [homosexual] men carried HPV." [December 8, 2000]

- Hepatitis: The Centers for Disease Control reports, "Outbreaks of Hepatitis "A" among men who have sex with men are a recurring problem in many large cities in the industrialized world."[Mortality and Morbidity Weekly Report, Sept. 4, 1998]
- Syphilis: The Archives of Internal Medicine found that homosexuals acquired syphilis at a rate ten times that of heterosexuals. [Issue 151; 1991]
- Gonorrhea, Gay Bowel Syndrome (GBS), and Anal Cancer.
- Every year approximately 10 billion dollars is spent on major STDs other than AIDS and their complications. This cost is shared by all Americans.
- 2. Mortality Rate: Today the average life span of heterosexual males is 75 and females is 79:

The average life span for homosexual males is 41 yrs. Lesbians is 45 yrs.

3. Homosexuals Have Very Few Long-Term Relationships:

Homosexuals have high numbers of partners. [A.P. Bell and M.S. Weinberg, Homosexuality's: A Study of Diversity Among Men and Women (New York: Simon and Schuster, 1978)] found:

- 74% of white male homosexuals had had sex with more than 100 partners
- 43% had had sex with 500 or more partners
- 28% had had sex with 1,000 or more sex partners

Thomas Schmidt, Straight and Narrow? "Only 8% of homosexual men and 7% of women have ever had a relationship that lasted more that 3 years. Tragically, lifelong faithfulness is almost nonexistent in the homosexual experience."

M. Pollak, Western Sexuality: Practice and Precept in Past and Present Times: ". . . few homosexual relationships last longer than two years, with many men reporting hundreds of lifetime partners."

David P. McWhirter and Andrew M. Mattison, The Male Couple: Stated all couples with a relationship lasting more than five years have incorporated some provision for outside sexual activity in their relationship." [1984]

4. Domestic Violence:

Gwat Yong Lie and Sabrina Gentlewarrier, "Intimate Violence in Lesbian Relationships," Journal of Social Service Research: In a survey of 1,099 lesbians, they found that "slightly more than half of the [lesbians] had experienced violence.

The Bureau of Justice Statistics (U.S. Department of Justice) reports that married women in traditional families experience the lowest rate of violence compared with women in other types of relationships. [Nov. 1994]

5. Depression and Suicide:

Thomas Schmidt: Straight and Narrow?

- Rate of depression: 40% for male homosexuals; 3% for male heterosexuals.
- Rate of attempted suicide: 18% for male homosexuals; 3% for male heterosexuals.

5. How Should We View Marriage? (8-Conclusions)

- All sex outside of marriage is sinful, whether Heterosexual or Homosexual. Sex in marriage is honorable; sex outside marriage is not - Heb 13:4
- 2. Marriage is a divine institution, not merely a civil one.

 Marriage was instituted by God at the beginning Mt 19:3-4
- 3. Marriage is for man and woman, who become 'one flesh' (Procreation of children) Mt 19:5

- 4. One may divorce and remarry, but still commit adultery Mt 5:31-32 God allows divorce only for fornication, and desertion and remarriage by the innocent Mt 19:9
- 5. Marriage throughout the Bible is always between a man and Woman. Marriage was designed for those created male and female Mt 19:4
- 6. There is not one mention regarding same-sex marriage in the Bible. (Though the practice was known among the Gentiles)
- 7. There is no teaching on how same-sex marriages work. (who is The head? who is to submit?)
- 8. In light of God's rejection of the sin of Homosexuality, God loves the homosexual. Because God loves homosexuals so should we. God does not want homosexuals to stay in their sin. His grace for forgiveness is available without restriction to all sinners.
